CBCA Annual Membership Meeting, January 13

The Bylaws of the Capitol Beach Community Association, Incorporated, call for an annual membership meeting to be held at 2:00 pm on the second Sunday in January of each calendar year. Wintertime Use of Bubblers/Aerators

Given the recent weather, an article regarding the appropriate use of bubblers on our lake seems timely.

The use of bubblers/aerators during the winter is not recommended by the CBCA. If a member chooses to use these devices, the following rules should be followed (as stated in the CBCA membership directory):

- Bubblers/ aerators when used during the winter months should be used with caution. Bubblers should not be operated when the temperature is above 28 degrees.
- Bubblers should be run only long enough to clear the ice away from an area, not to exceed 10' beyond the dock or boat lift.
- Ice should be allowed to reform to a depth of approximately ½ inch before the bubbler is reactivated.
- Bubblers should be monitored and managed effectively to comply with these requirements.
- Extreme caution should be used by anyone who goes on the ice in any part of the lake at any time.

Given the fact that the water level is always changing, you can consider having a small hole (approximately 4 inches in diameter) in the ice near your dock. This can be accomplished by simply chipping a hole in the ice (no bubbler needed).

For safety and water quality reasons, please abide by these bubbler rules. Allowing large amounts of open water will invite our unwanted geese friends. Reported violations of these rules will be reviewed by the board.

Thank you for your cooperation regarding our CBCA bubbler rules.

Water Quality

Remember that the lake level is continually changing during the winter months as the board works to reduce the salt content of the water. It will be lowered and then refilled by pumping water from Oak Creek as long as the ground is frozen and the creek water remains clean.

As the lake is refilled, residents should monitor their docks. If there is a thick layer of ice, dock posts could be lifted by the rising water. Bubblers used appropriately can prevent dock damage. Remember to adhere to the bubbler guidelines (found in the CBCA Membership Directory and elsewhere in this newsletter) and make sure open water does not extend more than ten feet beyond the dock or boat lift.

Skating on Thin Ice?

From the CBCA Board

Is it safe to skate on the ice? Can I cross-country ski across the lake? Below are excerpts from guidelines of the City of Lincoln Park and Recreation Department that will help answer those questions. These guidelines are generally accepted as minimum safety standards on clear, blue ice. Remember that Capitol Beach Lake does have springs, residents do use bubblers, and we are continually draining and refilling the lake, all of which can create air pockets and/or thin ice. ALWAYS USE EXTREME CAUTION when stepping on the ice!

- 2 inches will support one person.
- 3 inches will support a group in single file.
- 6 inches of ice is needed to support a large group.

Other general safety reminders:

- Never go out on the ice alone.
- Be careful in areas where springs are known to feed the lake.
- Watch for weak spots along the edges and near snow piles.

You can have fun on the ice and enjoy the lake in the winter too!

Snowmobiling Caution

Due to the use of bubblers by residents, because we have natural springs in our lake, and because we are continually changing the lake level, snowmobiling on the lake is not recommended by the CBCA board. Bubblers and the changing lake level may cause thin ice or may inject air under the ice which can cause thin spots to appear anywhere on the lake.

Capitol Beach Community Association

The Capitol Beach Community Association (CBCA) was incorporated on January 28, 1986, as a 501(c)(7) corporation. Every person who is a titleholder of a vacant lot or living unit abutting Capitol Beach Lake shall be eligible for membership in the corporation. Once a lot or living unit abutting Capitol Beach Lake has joined the Association, such property shall remain so subject in perpetuity, and may not be separated from the Association. The bylaws and protective covenants, as amended, are recorded with the Register of Deeds. Members of the Association are provided copies of these agreements when they join and upon request. The bylaws of the Association define how the business of the Association will be done, including meetings of the general membership, the election of board of directors at the annual meeting, and monthly board meetings. The bylaws also empower the board to establish rules and regulations of the Association for safety and care of the commons.
